and shape the future of an iconic historic house and garden – Highbury, the Birmingham home of Joseph Chamberlain

In 1932 Highbury Estate – Highbury hall and its gardens – was given in trust to the City of Birmingham. Since then it has been operated by Birmingham City Council as sole trustee. It has been used for many purposes, most recently as a banqueting and wedding venue run by the City Council's catering arm. Following a detailed options appraisal by Birmingham Conservation Trust, Birmingham City Council wishes to facilitate a fresh start for Highbury.

A new independent trust, the Highbury Heritage Trust, will be established and granted the estate's assets on at least a 25-year lease. The new trust will develop and implement a vision for Highbury. For anyone passionate about Birmingham's heritage this is an extraordinary opportunity to come in at the beginning of a transformational venture and shape the future of Highbury for a generation.

The Highbury Heritage Trust will start with a "windfall" development budget of c.£750,000.

The challenge:

- To develop a new overall vision for Highbury which will maximise the opportunities for public and community benefit while achieving long-term sustainability
- To imaginatively unlock the heritage of Highbury, engaging the widest possible audiences
- Building on the recommendations of the options appraisal, to develop an ambitious programme of repair and restoration of the house and gardens, which will transform Highbury over the next 10-15 years (estimated cost c.£7 million)
- To use the development budget to initiate and support the incremental programme of fundraising and grant applications that will be necessary to achieve the vision

The Chair will be the crucial first appointment, leading on the appointment of the other trustees (up to 7), overseeing the creation of the new charity, and shaping the vision of the Highbury Heritage Trust.

- To develop new skills, knowledge, contacts and friends
- To make a real difference to Birmingham and the local community
